PERUBAHAN TARIKH CUTI PENGGAL KEDUA PERSEKOLAHAN

Kementerian Pendidikan, Berakas/29 Zulhijjah 1442 bersamaan 09 Ogos 2021 – Berikutan perkembangan terkini mengenai COVID-19 seperti yang dimaklumkan oleh Kementerian Kesihatan, Kementerian Pendidikan dan Kementerian Hal Ehwal Ugama mengambil langkah berjaga-jaga bagi memastikan kesejahteraan dan keselamatan para pelajar dan warga sekolah dengan mengubah tarikh bermula cuti penggal kedua persekolahan daripada 12 September 2021 kepada **hari Rabu, 11 Ogos 2021 hingga hari Selasa, 17 Ogos 2021**. Perubahan cuti ini akan melibatkan semua sekolah rendah, menengah, maktab, pusat tingkatan enam dan sekolah swasta di bawah kawalan Kementerian Pendidikan dan juga sekolah-sekolah di bawah kawalan Kementerian Hal Ehwal Ugama.

Institusi pendidikan teknikal dan vokasional, pusat-pusat latihan dan pembelajaran sepanjang hayat dan institusi-institusi pengajian tinggi pula akan meneruskan pengajaran dan pembelajaran secara dalam talian melalui platform media sosial yang bersesuaian seperti yang telah bermula pada hari Isnin, 9 Ogos 2021. Mana-mana pelajar yang sedang menjalani penempatan kerja adalah dinasihatkan untuk mematuhi *Business Continuity Plan* (BCP) di tempat mereka menjalani penempatan kerja dan garis panduan latihan industri yang telah ditetapkan oleh institusi pengajian masing-masing.

Semua institusi pengajian juga diarahkan untuk mengaktifkan *Business Continuity Plan* (BCP) masing-masing dan pelaksanaan kaedah *Work From Home* (WFH) juga diselaraskan dengan kaedah *flexible working arrangements* bagi semua warga perkhidmatan awam seperti yang dinyatakan di dalam Surat Keliling Jabatan Perdana Menteri bilangan 06/2020.

Sebarang perkembangan terkini akan dimaklumkan melalui saluran rasmi media dan laman sesawang Kementerian Pendidikan dari semasa ke semasa tertakluk kepada perkembangan jangkitan pandemik COVID-19 ini serta nasihat daripada Kementerian Kesihatan yang akan dimaklumkan kemudian.

Kementerian Pendidikan dan Kementerian Hal Ehwal Ugama dengan kerjasama Kementerian Kesihatan akan terus memantau perkembangan kejadian jangkitan ini dan seterusnya mengingatkan warga sekolah dan institusi pengajian untuk sentiasa mengamalkan penjarakkan sosial, penjagaan kebersihan serta mewajibkan pemakaian sungkup muka apabila berada di tempat-tempat awam.

AMENDMENT OF THE SECOND SCHOOL TERM HOLIDAY

Ministry of Education, Berakas/29 Zulhijjah 1442 corresponding to 09 August 2021 – Subsequent to the recent COVID-19 announcement made by the Ministry of Health, the Ministry of Education and the Ministry of Religious Affairs are taking precautionary measures to maintain the well-being and safety of the students and school community by moving forward the second school term holiday from 12 September 2021 to **Wednesday, 11 August 2021 until Tuesday, 17 August 2021**. This applies to all primary and secondary schools, colleges, sixth form centres and private schools under the purview of the Ministry of Education as well as schools under the Ministry of Religious Affairs.

Technical and vocational institutions, training and lifelong learning centres and institutions of higher learning will continue online learning and teaching through suitable social media platforms which has started on Monday, 9 August 2021. Students undergoing work placement are advised to adhere to the Business Continuity Plan (BCP) at their work place and industrial training guidelines that have been set by their respective learning institutions.

All educational institutions are to activate their respective Business Continuity Plan (BCP) and implementing the Work From Home (WFH) method in line with the flexible working arrangements for all public servants as stated in the Prime Minister's Office Circular with reference 06/2020.

Further updates will be relayed via official media channels and the Ministry of Education website in due course subject to the development of the COVID-19 pandemic and advice from the Ministry of Health.

The Ministry of Education and the Ministry of Religious Affairs in cooperation with the Ministry of Health will continue to monitor the development of the pandemic and remind schools and educational institutions to always maintain social distancing and practice good-self hygiene as well as mandating wearing face masks in public places.
