# Tackling water issues together

**TOKYO, JAPAN, April 25** - Brunei Darussalam has been honoured with a meaningful opportunity to participate and share its endeavour on tackling water issues as well as learning through information sharing and experiences from other partner states at the 4<sup>th</sup> Asia-Pacific Water Summit held recently in Kumamoto City, Kumamoto.

Representing Brunei was Yang Berhormat Dato Seri Setia Ir. Awang Haji Suhaimi bin Haji Gafar, Minister of Development.

The summit commenced with an Opening Ceremony and Summit-Level Meeting on April 23, which was officiated by His Majesty Emperor Naruhito.

His Majesty in a keynote address expressed his concern and vision for a resilient generation to come through water actions and on the drive that the region can contribute especially how Japan can lead the world in addressing challenges associated with water.

His Majesty also emphasised the role of each level of society with emphasis on the involvement of youths, where he was confident and supported their involvement as parties who play a key role in achieving the Sustainable Development Goals (SDGs).

The emperor also encouraged mutual learning and sharing of experiences regardless of age or gender for the sustainability of future generations and called on Member States to support youth empowerment.

# Al-Quran - permanent asset to be harnessed

BERAKAS, April 18 - His Majesty Sultan Haji Hassanal Bolkiah Mu'izzaddin Waddaulah ibni Al-Marhum Sultan Haji Omar 'Ali Saifuddien Sa'adul Khairi Waddien, Sultan and Yang Di-Pertuan of Brunei Darussalam in a *titah* (roval speech) highlighted the benefits of reading and understanding the Al-Quran, and called on Muslims to make the holy book a lifelong companion to attain blessings in this world and in the hereafter.

Therefore, His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam stressed that this is why it is vital to read and understand the wisdom behind Al-Quran, and those who do will inevitably garner guidance and blessings from it.

His Majesty delivered the titah at the annual National Level Nuzul Al-Quran Celebration for 1443 Hijrah held at the International Convention Centre (ICC).

# Immunisation saves lives, ensures health

BANDAR SERI BEGAWAN, April 25 - This year, Brunei Darussalam joined World Health Organization (WHO) member countries in celebrating World Immunisation Week on April 24-30.

The celebration aims to raise awareness on the importance of vaccines, which can protect every age group from diseases and

Every year, World Immunization Week has a different theme that Mumps, Polio, and Tetanus. serves as the main platform to attract the attention of the world's population on issues related to immunisation.

This year's theme said the Minister of Health 'Long Life for All' was chosen with the aim of uniting all walks of life that vaccines enable us to pursue dreams, protect loved ones and live a long and healthy life.

The Minister said vaccination is one of the most important and cost-effective public health interventions in the prevention of diseases, which in turn addresses global health issues.

"This year's campaign comes at a very critical time as the COVID-19 pandemic has disrupted vital health services, including routine immunisations.

"In the past two decades, over 1.1 billion children have been immunised, saving four to five million lives each year, while halving child deaths worldwide," added the Minister.

Unfortunately, due to the COVID-19 pandemic, millions of people have lost the benefits of a life-saving vaccine. WHO reported that global vaccination coverage declined from 86 per cent in 2019 to 83 per cent in 2020.

The Minister shared that some 23 million children under the age of one did not receive the basic vaccine, the highest number since 2009.

In 2020, the number of fully unvaccinated children increased by 3.4 million. In addition, 1.6 million girls will not be fully protected from human papillomavirus (HPV) by 2020.

"Therefore," said the Minister, it is important for those who missed this to get the vaccine immediately."

According to the Minister, a systematic immunisation programme is one of the most important components in health care that should be given to every individual from the beginning of their age during infancy to adulthood.

"Alhamdulillah, we are fortunate as citizens and residents of Brunei to receive free vaccination services from the Government of His Majesty Sultan Haji Hassanal Bolkiah Mu'izzaddin Waddaulah ibni Al-Marhum Sultan Haji Omar 'Ali Saifuddien Sa'adul Khairi Waddien, Sultan and Yang Di-Pertuan of Brunei Darussalam through the Ministry of Health (MoH).

The National Children Immunisation Programme (children aged zero to five) is one of the programmes available at clinics and health centres nationwide. This is a step forward in expanding access to immunisation, especially among infants and children, in addition to achieving the Sustainable Development Goal 2030 and Universal Health Coverage," said the Minister.

With the National Children Immunisation Programme, Brunei Darussalam has achieved and maintained the rate of child immunisation at a level exceeding 95 per cent each year. Statistics of immunisation coverage rates among these children achieve the Sustainable Development Goal 2030 target.

"However," said the Minister, "the Ministry of Health (MoH) will continue to strive to improve the existing services so that this achievement can be maintained and also improved."

The Minister said, "among the very significant health impacts said the Minister is that giving vaccines to children can prevent diseases, disabilities, and deaths such as Hepatitis B, Measles,

Meanwhile, according to the Minister, the provision of vaccines for those at high risks, such as those suffering from various chronic diseases, food handlers and health workers (frontliners) can provide protection from various life-threatening diseases, such as influenza and meningitis which are commonly contracted at an early age."

"According to a WHO study, the administration of HPV vaccine specifically for girls in Year 7 has been shown to prevent or reduce the risk of cervical cancer as they grow into adulthood.In short, an appropriate immunisation programme has been proven to save lives and provide a higher quality of life, as well as ensure brighter future health for each individual," said the Minister.

"In relation to the national mandate which is based on the provisions under the Infectious Diseases Act 2003 Chapter 47 Section 1, parents or guardians must ensure that their children complete the vaccination schedule to protect against infectious diseases according to Schedule 4 of the act which covers 10 types of diseases - Diphtheria, Haemophilus Influenza B, Hepatitis B, Measles, Mumps, Pertussis, Polio, Rubella, Tetanus, and Tuberculosis.

"I advise parents to ensure that their children have received a full immunisation according to the set schedule and use the facilities provided by the government through health centres and clinics," added the Minister.

The Minister also touched on the ongoing commitment of His Majesty's Government, especially the immunisation programme for the high risk and public healthcare, which has made the Sultanate one of the countries declared free of Malaria by the WHO in 1987; free from Polio in 2000; free from Measles in 2015 and free from Rubella in November 2018.

"We should continue and maintain this achievement, and we must continue to strive to achieve the same achievement for various other types of diseases, InsyaaAllah," said the Minister.

In the context of COVID-19, the people and residents of Brunei are fortunate as the government had implemented the National COVID-19 Vaccination Programme from April 3, 2021 in stages according to the phases outlined in the Vaccination Strategy of Brunei Darussalam.

As of April 23, some 1,107,691 doses of the COVID-19 vaccine have been administered nationwide - 94.5 per cent of the population have received at least two doses and 64.1 per cent a booster.

The National COVID-19 Vaccination Programme for adolescents aged 12 to 17 and children aged five to 11 have shown encouraging responses.

"On this occasion, in support of the theme of this year's World Immunisation Week, the Ministry of Health is committed and will continue to work to further strengthen immunisation services at Brunei Darussalam for children and strive to increase immunisation coverage for those at high risk at all ages.

"I hope this year's World Immunisation Week will encourage citizens and residents of Brunei Darussalam to value health, be more responsible in ensuring proper vaccination to achieve 'Long Life for All', to realise the MoH's vision of 'Together Towards A Healthy Nation' and to achieve Brunei Vision 2035 of High Quality of Life of the Population," said the Minister.

ASEAN Finance Ministers and Central Bank Governors exchanged views with the International Monetary Fund (IMF); the World Bank (WB); the Asian Infrastructure Investment Bank (AIIB); the Asian Development Bank (ADB); and the ASEAN+3 Macroeconomic Research Office (AMRO) on the regional and global outlook, in particular risks and opportunities, as well as policy recommendations, to foster a resilient, sustainable and inclusive recovery.

In his intervention, the Minister at the PMO and Second Minister of Finance and Economy emphasised the need for ASEAN to continue with collective efforts to ensure ASEAN remains an attractive investment destination.

The Minister also said it is important for the people of ASEAN to be equipped with the right mentality and skills to take advantage of opportunities arising from the new norm, which can further strengthen recovery.

He also shared the importance of building green and sustainable infrastructure as part of economic recovery efforts and encouraged multilateral development banks to assist member states to reach the goal.

The meeting concluded that as the pandemic recedes most economies are ready to re-open. However, the focus to alleviate the impact of the pandemic and support economic recovery

As uncertainty and volatility of the global environment increase, the policy mix needs to remain supportive and ASEAN members are encouraged to continue to undertake reforms that will spur recovery.

In continuing the ministerial engagements with the private sector, the meeting held a dialogue with the ASEAN Business Advisory Council, the ASEAN-EU Business Council, and the ASEAN-US Business Council to discuss enhancing regional efforts on digitalisation and sustainability.

The Minister acknowledged the relevance of digitalisation and green growth to ASEAN's economic growth agenda.

Recalling the adoption last year of regional frameworks to advance cooperation in the Bandar Seri Begawan Roadmap: An ASEAN Digital Transformation Agenda; ASEAN Framework on Circular Economy; and ASEAN Taxonomy on Sustainable Finance (Version 1), he also shared Brunei Darussalam's pursuit of reforms in promoting digitalisation and green transition.

# The BSI index increase

Central Bank (BDCB) published the Business Sentiment Index (BSI) for Brunei Darussalam for March 2022.

This index is based on surveys conducted on more than 500 micro, small, medium, and large-sized businesses from the 11 economic sectors in the Sultanate.

The monthly index is designed to measure the level of business confidence and sentiment in the Sultanate and cover various aspects including current and future business conditions; current and future investments, current and future employment of workers; as well as current and future costs of running the businesses.

Therefore, BSI serves as a leading macroeconomic indicator with its forward-looking element.

Within the BSI, there are nine sub-indices. The current business conditions sub-index, which is the main headline index for the BSI, was 50.3 in March. This was the sixth expansion since October 2021, slightly higher than the 50.1 recorded in February this year.

Several factors cited by businesses include increasing oil prices, more business activities, higher demand from the government and the public, as well as more projects compared to the month before.

However, several businesses observed worse or similar conditions than February from the impact of the highly transmissible Omicron variant that had reduced the number of customers frequenting the stores and also the reduction in manpower with employees undergoing quarantine orders either

to combat the climate crisis.

He cited the recent 'Our Oceans Conference', co-hosted by the US and Palau, as an example of international cooperation in tackling challenges like ocean warming, sea level rise, and ocean acidification.

The US Embassy will host the annual YSEALI Summit in June, featuring over 100 young climate leaders across South East Asia to discuss solutions for a warming planet.

> The investment sub-index was 50.1 for the current month, 50.6 for one month ahead, and 50.1 for three months ahead, indicating that general businesses have increased investment activities and inventory in March.

> Some have plans to increase investment expenditures in April such as improvement of office infrastructure and business premises and purchases of equipment, company vehicles, and raw materials

> The employment sub-index was 50.2 for the current month and 50.2 for the month ahead, indicating that most businesses were hiring more employees in March and will continue to hire in the next month.

> Overall, businesses still faced an overall shortage of workers as they were unable to replace the foreign workers whose permits expired and have to return to their home countries.

> Businesses also faced difficulties to secure local workers to fill the gap and some resorted to hiring part-timers. Despite this, businesses hope for an improvement in the procurement of labour procedures and welcome any efforts to resolve the

persistent manpower challenges.

The costs sub-index was 50.2 for the current month and 50.2 for the month ahead. This indicates that businesses continued to face increased costs of running their businesses in March and April.

Businesses expressed concerns regarding the rising costs over the months which in turn had lowered their profits.

In general, businesses cited increases in the prices of ingredients such as meat and raw materials such as fertilisers and oil, plus higher freight and shipping costs.

Higher operational costs are also caused by additional employee-related expenses such as paying overtime to existing employees to cover manpower shortages, and the purchase of

# RPPI increases by 7.6 per cent in Q4 2021

BANDAR SERI BEGAWAN, April 5 - Brunei Darussalam Central Bank (BDCB) yesterday published Brunei Darussalam's Residential Property Price Index (RPPI) for the fourth guarter of 2021 (Q4 2021).

The index was compiled using data sourced from banks The overall median price for all types of private residential in Brunei Darussalam and is published with close cooperation properties was \$264,000 in Q4 2021, an increase of 7.8 per cent from the Ministry of Development (MoD), in particular compared to the previous year and an increase of 5.6 per cent the Authority for Building Control and Construction Industry compared to the previous quarter. (ABCi).

Based on the transactions in Q4 2021, the RPPI was at 97.4, showing a 7.6 per cent increase year-on-year, and a 4.3 per cent increase guarter-on-guarter. This shows a continued increasing trend from the previous quarter.

# CPI increases 2.2 per cent in December 2021

The majority of these transactions were for detached houses at 62.5 per cent; semi-detached houses at 11.7 per cent; terrace houses at 18.7 per cent; apartments at 5.5 per cent; and land at 1.6 per cent.

The median purchase prices for specific types of properties for Q4 2021 were \$295,400 for detached houses; \$255,000 for semi-detached houses; \$219,400 for terrace houses; \$240,000 for apartments; and \$187,500 for land.

For 2021, the CPI increased by 1.7 per cent compared to 2020. The food and non-alcoholic beverages index and the non-food index increased by 2.4 per cent and 1.6 per cent, respectively.

The increase in the food and non-alcoholic beverages index was mainly due to the rising prices of beef, buffalo, and chicken meat. Meanwhile, the increase in the non-food index was mainly due to the increase in the costs of transport as well as restaurants and hotels.

The CPI is a measure of price changes of goods and services paid by the consumer in a specified period and compiled monthly.

The list of goods and services in the CPI is based on the average expenditure per household from the Household Expenditure Survey (HES).
